Federal Court and Federal Circuit Court Regulation 2012

Notes:

- 1) Other than for items 206, 208, 217 and 223:
 - (a) “corporation” includes a publicly listed company and any other corporation; and
 - (b) Public authorities, small business and not-for-profit associations are regarded as “other”.
- 2) For items 206, 208, 217 and 223, publicly listed companies pay the highest rate of fees, corporations and public authorities both pay the middle rate and all others pay the lowest rate.
- 3) Court fees are GST exempt
- 4) Fees (other than 202, 209, 210 and 220 are subject to biennial increase under section 2.20
